1. What Are Cookies?

Cookies are small text files placed on your device when you visit a website. They help websites function properly and efficiently, remember user preferences, and gather analytics data. Cookies may be set by the site you're visiting (first-party cookies) or by third-party providers (third-party cookies).

2. Types of Cookies We Use

We use the following categories of cookies:

a. Strictly Necessary Cookies

These cookies are essential for the site to function and cannot be turned off. They are usually set in response to actions such as logging in, filling out forms, or setting privacy preferences.

Examples:

- Session management cookies
- Authentication tokens
- Security and fraud prevention cookies

b. Performance and Analytics Cookies

These cookies collect anonymized data to help us understand how visitors use our site and Services, so we can improve them.

Examples:

- Page view tracking
- User journey analytics
- Error reporting

We may use services such as **Google Analytics**, which use their own cookies. For more details, see <u>Google's privacy policy</u>.

c. Functionality Cookies

These cookies enable enhanced features and personalization, such as remembering user preferences or saved projects.

Examples:

- Remembering your language or region
- Saving project state or dashboard preferences

d. Targeting and Marketing Cookies

These cookies may be used to deliver relevant ads to you or limit the number of times you see an ad. They may also be used by advertising platforms to build user profiles.

Note: Luna currently does not use targeted advertising cookies.

3. Legal Basis for Use of Cookies

For cookies that are not strictly necessary, we rely on your **explicit consent**, as required under the **EU ePrivacy Directive**, **GDPR**, and similar laws.

Where applicable, you will be presented with a **cookie consent banner** upon your first visit. You may change or withdraw your consent at any time by accessing the **Cookie Preferences** section.

4. Managing Your Cookie Preferences

You can manage your cookie preferences in two ways:

a. Through Our Site Tools

Click the "Cookie Settings" link (usually in the footer) to update your consent choices.
